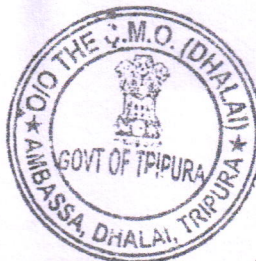

With reference to the subject cited above, a joint team of District Health Officer and Food Safety Officer conducted an inspection of sanitary and hygienic conditions of Eklavya Model Residential School, Ambassa on 11-6-2024. On inspection, it was found that the school meets the basic hygiene and sanitary conditions in the school premise and kitchen also. The school supplies safe drinking water to all the students and staffs of the institution. Water testing certificate from DWS, Ambassa was available as a record for safe drinking water.

Certain suggestions were given.

- i) Potable water testing to be done semi-annually i.e., twice a year.
- ii) Annual medical examination of the food handlers is recommended.
- iii) Personal cleanliness of food handlers must be maintained.
- iv) No signs of pest activity or infestation to be checked for regularly.
